Notice Regarding Changes to Representative Director, Candidates for Directors, and Executive Officers Personnel

Japan Display, Inc. ("JDI") announces it has decided the following changes, etc. at the board of directors meeting held today; (i) changes to the representative director and the executive officers personnel as of May 15, 2019, (ii) the executive officers as of May 16, 2019, (iii) candidates for directors for approval at JDI's annual general meeting of shareholders to be held on June 18, 2019 (the "Shareholders Meeting"), and (iv) changes to the representative director to be decided at the board of directors meeting to be held after the Shareholders Meeting.

As stated in the announcement made on May 13, 2019, titled "(Update and Progress of a Disclosure Matter) Concerning the Disclosure as of April 12, 2019", candidates for directors designated by Suwa Investment Holdings, LLC (the "Expected Allottee") (such directors, the "Designated Directors by Expected Allottee") will not be appointed at the Shareholders Meeting, and will be appointed at the extraordinary general meeting of shareholders which will be held after the Shareholders Meeting.

1. Changes in Representative Director

(1) Reason for the Changes

Nobuhiro Higashiiriki, Chairman and Representative Director of JDI, who has been on sick leave, has made a request to retire for health reasons, and JDI accepted the request today.

With the resignation of Higashiiriki, JDI will have one representative director, Yoshiyuki Tsukizaki. However, JDI will install Sadahiro Numazawa, who is an executive officer, as another representative director in order for JDI to address important issues, such as resolute implementation of structural reforms aimed at rebuilding business to overcome the severe business conditions JDI faces, and measures for the capital and business alliance with the Expected Allottee, under a two-representative director structure leading JDI's management.
